 - Over 300 photos, lots of positive press
- o Digital Art Screens between Freshii and Cougarbyte will display the pictures from Dear World Report from Director, Student Centers (Eve Esch)
 - Wayfinding concept is to help patrons get from point A to B with ease; Vendor selected: Cineviz, Cineviz will create mock ups of the floor maps (interactive), location: red wall by the information desk, the interactive map will have a "you are here beacon", main screen will be a map with all three floors and if you touch the screen then you will have event services and other items in the building, room name/number concern, idea to have the ability to click on the room to give a list of the events in the room; fixed signage on all of the floors but they will not be interactive; phase 2 touch screen in other areas of the building; after installation of wayfinding map in the SC South then will address the SC North,
 - Art Update new installation of the two digital signs, Eve is in contact with art professors to inform them that their students can use the screens to exhibit their digital art or other art pieces, idea/concern to change the current art on display fresh art cycling throughout the years art board is reviewing different options for the wall outside of the midtown and photography exhibit
 - Satellite with the Quads going down, another DSAES department has contacted the SC to seek office places, timeline: Summer 2017 move in, with intent to charge auxiliary services for their portion of the space issue, the CSM formally used the space

Report from Assistant Director, Facilities and Operations (Matthew Sebby)

• Microwave update – had problems with the microwaves that we had, one caught on fire was removed, replaced all microwaves with commercial microwaves, student concerns: the # of microwaves in the Student Centers; SC Admin addressing the # of microwaves in the building, redoing the space to help with the crowds that use the area at different times of the day, potential to move the tables/chairs out of that area and place under the staircase by Starbucks; thus far, the SC Facilities and Operations crew have

- removed the smoke detectors and replaced with heat detector and are getting quotes for adding additional microwaves/cabinetry
- Increasing the # of refillable water bottle dispensers all water stations will have a refilling dispenser
- World Trade Center 9/11 monument currently there is decomposed gravel, working to getting this replaced with a hard surface, seeking to have be no maintenance or low maintenance, installing drainage in the area, goal is to have it completed by 9/11/2017,

- Recommended Changes to Bylaws:
 - Article III: Officers, Section 1: Chairperson replace "Assistant Vice President for Student Affairs
 Student Life" with "Director of Student Centers" in # 4 & # 5
 - Article X: Standing and Special Committees, Section 1 Combine "Student Organization Carrel and Office Space Assignment Committee" with "Lease Operations & Student Organization Space Committee"
- SC South Plaza Design
 - Project based money from SFAC, will look into the design standard parameters,
 - Concerns with the design concepts presented: Solar powered concern of corrosion, maintenance on the stations, underutilization of charging stations, will look at the numbers of utilization green products vs traditional electricity, skateboarders concern,
- Building Hours of Operation the board had no concerns regarding the proposed changes to the building hours of operation

VIII. New Business

- Legacy Lounge Piano Note: Jason Wipf requested discussion on putting up a note to inform pianist to be
 considerate of the individuals in that area, censorship concern, SC is supportive of student endeavors and
 finds cause for concern with regards to putting up a note, KTK thoughts: The SC has ample space for
 students to relocate themselves if they seek a quite space, the questions of the legacy lounge as a
 reserveable space or not was brought to the boards attention, request to place a note was considered not
 necessary
- 4 person seating policy in the Food Court Jason Wipf took a picture taken of this area at 12:30pm, there
 were lines at all of the restaurants, there were no open seats, the thought is to create a policy to ensure
 that all space is being utilized, an example at Purdue University of table tents that encourage folks to sit
 together, designated areas for shared space and single use area, Eve will find the information from
 Purdue and share with the group for table tent consideration
